RECORDING OF INFORMATION

Indian vultures are a keystone species in their habitats. They have been listed as Critically Endangered on the IUCN Red List since 2002, as their population has severely declined over the past few decades. It is estimated that there are 5,000-15,000 mature individuals in wild.



Why should we save Vultures:

Vultures are scavengers, i.e. they feed on the carcasses of dead animals thus cleaning up the environment. This helps prevent the spread of diseases and maintains the ecological balance. And so, a decline in the vultures' population directly impacts the environment.



Why dicolofenac banned in India:

The veterinary use of Diclofenac has been already banned by the Government of India in 2006 - after a big decline in vulture population in the country. This is one of the big successes for the Mumbai-headquartered Bombay Natural History Society (BNHS).



What is the save for vulutre project:

SAVE stands for Saving Asia's Vultures from Extinction and it is a consortium of like-minded, regional and international organisations and has been created to oversee and co-ordinate conservation, campaigning and fundraising activities to help the plight of south Asia's vultures.

To Prevent the poisoning of the principal food of vultures, the cattle carcasses, with veterinary NSAIDs, by ensuring that sale of veterinary NSAIDs is regulated and is disbursed only on prescription and by ensuring that treatment of livestock is done only by qualified veterinarians.



What is the vulutre action plan for 2025:

The new plan automatically removes veterinary use of a drug if it is found to be toxic to vultures. This is to be done with the help of Drugs Controller General of India. Under the plan, every state will host at least one vulture safe zone to conserve the remnant population of vultures in the state.
